ARTICULATIONAGREEMENT

Between

THE CHRIST COLLEGE OF NURSING AND HEALTH SCIENCES

and

CINCINNATI STATE TECHNICAL AND COMMUNITY COLLEGE

THIS ARTICULATION AGREEMENT (the "Agreement") is entered into on the date of last signature below (the "Effective Date") by and between The Christ College of Nursing and Health Sciences ("TCCNHS"), with an address at 2139 Auburn Avenue, Cincinnati, OH 45219; and Cincinnati State Technical and Community College ("CSTCC"), with an address at 3520 Central Parkway, Cincinnati, OH 45223. TCCNHS is a private, non-profit institution of higher education approved by the Ohio Department of Higher Education to offer associate and bachelor's degree programs. CSTCC is a public institution of higher education approved by the Ohio Department of Higher Education to offer associate degree and certificate programs. TCCNHS and CSTCC agree that students of TCCNHS are eligible for articulated course credits at CSTCC, according to the terms contained in this Agreement.

ACCORDINGLY, in consideration of the promises and mutual covenants contained in this Agreement, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Description of Articulation Program.

- a. <u>Definitions</u>. Articulation Criteria and Articulation Benefits are defined on <u>Attachment A</u>.
- b. <u>Articulation Benefits to Students</u>. TCCNHS will provide the Articulation Benefits at no charge to past and present students of CSTCC who meet the Articulation Criteria.
- c. <u>Accreditation of the TCCNHS</u>. TCCNHS warrants that it is accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools. TCCNHS will notify CSTCC if such accreditation ceases to exist.
- d. <u>Accreditation of CSTCC</u>. CSTCC warrants that it is accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools. CSTCC will notify TCCNHS if such accreditation ceases to exist.
- e. <u>Admissions Processing</u>. For those past or present students who meet Articulation Criteria found in Attachment A, TCCNHS will consider their applications for admission in accordance with standard TCCNHS admission application evaluation criteria, while favorably recognizing students' accomplishments at CSTCC.
- f. <u>Non-Exclusivity</u>. This Agreement is not exclusive, and either party may enter into similar agreements with any other party.

2. Term and Termination.

- a. <u>Term.</u> This Agreement has an initial term of one (1) year. Thereafter, this Agreement will automatically renew on a year-to-year basis for up to four (4) additional one-year terms unless either party gives the other a minimum of thirty (30) days prior written notice of non-renewal.
- b. <u>Termination</u>. Either party may terminate this Agreement in the event of a material breach by the other party, effective upon the later date to occur of (i) the end of the next admissions application and review period of TCCNHS, or (ii) the date that is 90 days after the notice that includes a description of the breach; *provided* in either case that the breaching party shall be allowed until said effective date to cure said breach, and if the breach is so cured the termination notice will be of no effect.
- c. <u>Post-Termination</u>. Upon expiration or termination of this Agreement for any reason, CSTCC students previously accepted by or admitted to TCCNHS shall continue to receive the benefits contemplated by this Agreement.

3. Miscellaneous.

- a. <u>Severability</u>. If any Section or provision of this Agreement be held illegal, unenforceable, or in conflict with any law by a court of competent jurisdiction, such Section or provision of this Agreement shall be deemed severed from this Agreement and the validity of the remainder of this Agreement shall not be affected thereby.
- b. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of Ohio applicable to contracts made and to be enforced wholly within Ohio.
- c. <u>Jurisdiction: Venue.</u> The parties to this Agreement each specifically consent to jurisdiction in Ohio in connection with any dispute between the parties arising out of this Agreement or pertaining to the subject matter hereof. Venue for any dispute between the parties arising out of this Agreement or pertaining to the subject matter hereof will be in the state and/or federal courts residing in Hamilton County, Ohio.
- d. Survival. Sections 2(c) and this Section 3 will survive termination or expiration of this Agreement.
- e. Notices. All notices or other written communications relating to termination, expiration, or any other legal matter relating to this Agreement will be effective when received in accordance with this Section 3(e) and must be given in writing by courier or reputable overnight delivery service, or by certified mail, return receipt requested, to either party at the following address (or to such other address as such party may substitute, by providing a written notice in the manner specified in this Section) with, in the case of the HTC, an additional copy addressed to "General Counsel":

- f. Waivers and Amendments. The waiver by either party of any provision of this Agreement on any occasion and upon any particular circumstance shall not operate as a waiver of such provision of this Agreement on any other occasion or upon any other circumstance. This Agreement may be modified or amended only via a writing signed by both parties.
- g. <u>Assignment</u>. Neither party may assign its rights or delegate its duties under this Agreement. Any attempted assignment or delegation in violation of this Section would be null and void.
- h. <u>Complete Agreement: Integration</u>. This Agreement contains the complete understanding of the parties with respect to the subject matter hereof and supersedes all other agreements, understandings, communications and promises of any kind, whether oral or written, between the parties with respect to such subject matter.
- i. <u>Counterparts: Facsimile Signatures.</u> This Agreement may be executed in multiple counterparts, all of which shall be originals and which together shall constitute a single agreement. For the purpose of interpreting this Agreement, facsimile signatures shall be considered equivalent to original signatures.
- j. <u>Independent Contractors.</u> The parties are independent contractors, and no agency, partnership, franchise, joint venture, or employment relationship is intended or created by this Agreement. Neither party shall make any commitment, or give the impression that it has authority to make any commitment, on behalf of the other party.
- k. <u>Compliance with Laws/Non-Discrimination</u>. The parties will comply with all applicable laws and regulations in performing their obligations hereunder. When taking actions (or failing to act) in any way relating to this Agreement, each party agrees that it will not unlawfully discriminate against any person on the basis of race, sex, religion, disability, age, national origin, citizenship, sexual orientation, gender, gender identity, genetics, military or veteran status; color, or any other characteristic protected by local, state, or federal law.

INTENDING TO BE LEGALLY BOUND, by signing below, each party acknowledges its agreement with the terms and conditions of this Agreement and each signatory represents and warrants that he/she is authorized to sign on behalf of and to bind his/her party to all of the terms and conditions of this Agreement as of the Effective Date.

Attachment A To The Articulation Agreement By and Between CSTCC and TCCNHS

Articulation Criteria and Articulation Benefits

The Bachelor of Science Degree requires a minimum of 120 credit hours. Students may transfer in general education courses and/or select elective and major courses to meet the criteria. Students must complete at least 30 credit hours at TCCNHS.

- 1. The articulation criteria ("Articulation Criteria") are:
 - a. Completion of the Pre-Business Administration (PBA) program with a minimum of sixty-four (64) semester hours.
 - b. Courses required by the CSTCC Pre-Business Administration program that would transfer consist of the following:

- e. In addition to the 64 credit hours in the PBA program, students may transfer an additional 7 credit hours of unrestricted general elective courses from any discipline which will be needed to fulfill the bachelor's degree credit hour requirements. These electives may be taken at CSTCC and be transferred for the bachelor's degree.
- f. All transferred courses must attain a minimum grade of C and a cumulative 2.0 grade point average on a 4.0 grade scale.
- g. CSTCC students transferring to TCCNHS will be required to meet any additional required general education courses and all residency requirements to receive a degree from TCCNHS.

2. The articulation benefits ("Articulation Benefits") are:

- a. Certain CSTCC course credits will transfer as equivalent to TCCNHS course credits, as set forth in the Credit Transfer Table: See Amendment A
- b. Certain TCCNHS course credits will need to be completed successfully at TCCNHS in order to obtain a Bachelor of Health Care Administration from TCCNHS: See Amendment B
